1 **IT IS HEREBY ORDERED:**

2 1. KCC LLC, the third party administrator, is to update the LADWP Billing Settlement  
3 Website (<http://www.ladwpbillingsettlement.com/>) to reflect the appointment of Brian S. Kabateck  
4 of Kabateck LLP as new class counsel. Revisions to the website include but are not limited to the  
5 following:

6 a. **Frequently Asked Questions, No. 2:** remove the reference to Jack Landskroner and  
7 his law firm as the point of contact for class member questions and replace with

11 Michael Libman, and their respective law firms, as the lawyers representing the  
12 class and replace with “ Brian S. Kabateck of Kabateck LLP, 633 W. Fifth St., Suite  
13 3200, Los Angeles, California 90071 was appointed as new class counsel at a  
14 hearing on April 17, 2019 and by written order on May 7, 2019. Kabateck LLP has  
15 been appointed by the Court to represent you and the other Settlement Class  
16 Members.”

17 c. **Frequently Asked Questions, No. 12:** remove the reference to Landskroner Greico  
18 Merriman as “Class Counsel” or revise to the past tense;

19 d. **Frequently Asked Questions, No. 20:** remove the reference to Jack Landskroner  
20 and his law firm as the point of contact for requesting additional information and  
21 replace with “Brian Kabateck of Kabateck LLP, 633 W. Fifth Street, Suite 3200,  
22 Los Angeles, CA, 90071;

23 2. Jack Landskroner and his law firm, Landskroner Greco Marriman are no longer lead  
24 class counsel and Michael Libman is no longer “liaison counsel” in this action. There should be no  
25 reference to them in this capacity.

26 3. Class Counsel, Kabateck LLP, should further instruct KCC to make any additional  
27 revisions necessary to reflect their appointment as attorneys of record;

28 4. Notice to class members of these changes is not required.



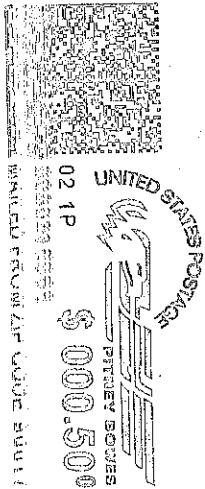
